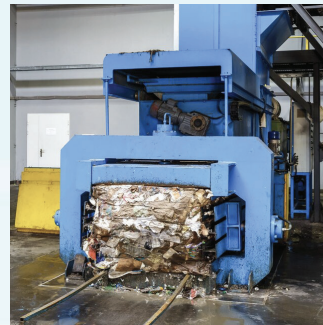

Recycling Disposable Diapers: A Complex Challenge

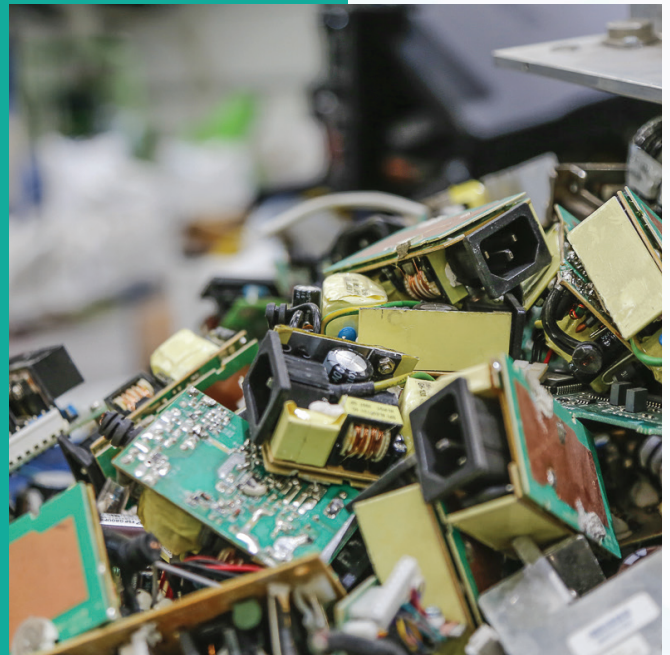

Made from various materials like polypropylene, polyethylene, and superabsorbent polymers (SAP), these diapers are not easily biodegradable. When discarded, they contribute to landfill waste and can take hundreds of years to decompose. Recycling disposable diapers is a complex issue that requires innovative solutions and collaborative efforts. By understanding the challenges and supporting sustainable practices, we can reduce the environmental impact of these products and move towards a more circular economy.

Material Complexity:

The combination of different materials, including plastic, pulp and SAP, requires advanced separation techniques.

Energy Intensive:

The recycling process itself can be energy-intensive, potentially compensating some of the environmental benefits. This technology involves a multi-step process to separate and clean the different components of diapers. The recovered materials can be used to produce new products like plastic pellets paper pulp and SAP can be reused in manufacturing of diapers.



Diaper Recycling Machines:

These machines use physical separation techniques to recover SAP, pulp, and plastic from diapers. The recovered materials can be further processed and reused.

The Solution:

Our R&D team has developed a first-of-its-kind machine that can efficiently separate and recover the key components of defective online manufactured diapers. This innovative technology minimizes environmental impact by enabling the reuse of polypropylene, superabsorbent polymer and pulp. This machine is in use in our facility ever since 2004. As pioneers, we are the sole owners of this revolutionary technology in Saudi Arabia, unmatched across Asia and the Middle East.
